GRAFFITI PEEL for Digital Printed Signs

This product has been recently developed and is protected by an International Patent Application No PCT/AU2011/001425. The system is not limited to reflective signage - it is all encompassing to "Removal of markings off a substrate".

CONCEPT

Graffiti Peel is a simple, cost effective system for the easy removal of graffiti from digital printed signs on self adhesive vinyl and banner vinyl.

PROTECT Apply a coat of Graffiti Peel. This is a water based coating that can be applied by brush, pad applicator, spray or screen laminator. It is water resistant, scratch and mar resistant and non-yellowing. It dries clear and is almost undetectable.

TAPE Once the sign is graffitied then self adhesive tape is applied to the total sign or just onto the graffitied areas. The tape is firmly squeegeed to the substrate to form a strong bond.

REMOVE The clear protective coating along with the graffiti and tape is then peeled from the sign, leaving the sign free of graffiti and in its original condition. Alternatively the signs can be blasted with a high pressure washer to remove the protective coating and graffiti.

REAPPLY To protect the sign again it is recoated with a single coat of Graffiti Peel.

EXISTING GRAFFITI SYSTEMS

HASSLE Most graffiti systems are permanent coatings which require the use of hazardous solvents or paint removers to dissolve the graffiti then clean it off. It can be very time consuming to remove the graffiti.

INEFFECTIVE In some instances the graffiti cannot be completely removed and a "ghosting" remains. Careful solvent selection is also required to remove graffiti otherwise the clear can discolour (whiten) and the sign is ruined.

EXPENSIVE These coatings are also very expensive. Two pack coatings are normally used and generally require two coats. They can often require 7 days curing to become graffiti resistant.

HAZARDOUS The solvents used to clean off graffiti are generally classified as hazardous and in most cases are a dangerous good (ie flammable). They pose Health and Safety risks.

This new concept overcomes all these short comings.

THE GRAFFITI PEEL SYSTEM has many advantages

SIMPLE Protect, tape and peel (or high pressure wash)

EFFECTIVE Graffiti is completely removed and no "ghosting "is apparent. After 2 hours

curing the sign is protected against graffiti attack.

SAFE TO USE No need to use solvents so there are **no** Health and Safety issues

LOW COST Cost effective – One coat of Graffiti Peel Clear at a cost of approx \$2.80 per

square metre. The adhesive tape cost is approx \$1.

UV PROTECTION The clear contains UV absorbers so the sign has some protection

against the sun and weather.

LONGER SERVICE LIFE The signs will last longer. Remove the clear at anytime and the

sign is in its original condition.

EASY STICKER REMOVAL If stickers are applied to the sign they can be easily peeled off

without damage to the sign.

QUICK Graffiti can be removed quickly on site or the signs can be replaced and then

rejuvenated off site ready for another installation. It could be possible to

double the life of a sign.

DURABILITY OF THE CLEAR

The durability of this clear coating is excellent. We have been using this clear in other exterior signage applications and have practical experience of over 12 years. It is a permanent clear coating and is non-yellowing and therefore the coating does not alter the visual aspect of the sign. The signs can be brought back to life at any time by removing the protective coating and applying a fresh coat.
